Lebel Mansion Public Space Rental Policy

Effective Date: October 10th, 2017

Note: "Public Space(s)" defined hereafter as the Lebel Mansion second floor boardroom, the basement classroom and third floor space at the north end of the building.

Non-Lebel Mansion Tenant Public Space Rental

- All Public spaces are rented at \$15.00 per hour with a maximum charge of \$75.00. The Tenant may use the space for two additional hours beyond that point for a maximum use time of seven hours per rental day.
- Spaces must be booked through the Allied Arts Council Staff.
- Rental payment must be paid before or upon departure from the Lebel Mansion.
- · Spaces must be left in the same condition as upon arrival.

Lebel Mansion Tenants in good standing with the AAC Public Space Rental

- To conduct meetings, or business related functions that do not produce a profit the space can be used free of charge. Tenants must book the space with a member of the Allied Arts Council Staff.
- Space use for profit by a Tenant: all Public Spaces are rented at \$15.00 per hour with amaximum of \$75.00. The Tenant may use the space for an additional two hours beyond that point for a maximum of seven hours per rental day.
- Spaces must be booked through the Allied Arts Council Staff.
- Rental Payment must be paid before or upon departure from the Lebel Mansion.
- Spaces must be left in the same condition as upon arrival.

Noise

- The Lebel Mansion is a public space used by many different individuals and businesses. Please refrain from excessive noises while in the building.
- The Allied Arts Council reserves the right to remove the renter(s) from the Lebel Mansion should a noise complaint be made from a Tenant or the Allied Arts Council Staff Member.

Personal Belongings

 Personal belongings brought in or left in the rental space are the responsibility of the renter and cannot hold the Allied Arts Council of Pincher Creek accountable for the loss or damage of personal property.

Amenities

- Public Spaces are rented "as is", kitchen is available for use and bathrooms throughout the building are for public use.
- Art Supplies located in the Lebel Mansion are for the use of programs, not for Public Rental use.
